At a regular meeting of the Township Board for the Charter Township of West Bloomfield, Oakland County, Michigan, held on September 9, 2013 at the Township Hall, 4550 Walnut Lake Road, West Bloomfield, Michigan, the following preamble and resolution were offered by Trustee Brown, and supported by Trustee Rosenberg:

**WHEREAS**, on May 20, 2013 the Township Board for the Charter Township of West Bloomfield found that a need has emerged to study and develop regulations, for the public health, safety and welfare, applicable to establishments that operate smoking lounges and facilities commonly described as Tobacco Retail Specialty Shops, Cigar Bars, 0% Nicotine Establishments, Hookah Lounges and Bars, and other Smoking Facilities by any other name; and

**WHEREAS**, the Township Board found that it would be counterproductive to approve the operation of these establishments within the Township while the Township studies and develops and adopts applicable, consistent regulations; and

**WHEREAS**, the Township Board has determined that the consistent, cohesive and objective land use, development and regulatory standards for the operation of Tobacco Retail Specialty Shops, Cigar Bars, 0% Nicotine Establishments, Hookah Lounges and Bars, and other Smoking Facilities by any other name being developed by staff will not be adopted and in effect prior to the expiration date of the moratorium adopted on May 20, 2013.

**THEREFORE, BE IT RESOLVED**, that the attached Moratorium on Smoking Lounges and Facilities adopted May 20, 2013 shall be extended and all provisions thereof shall remain in effect until February 20, 2014; however, in the event the land use and regulatory ordinances are adopted and in effect prior to February 20, 2014, the moratorium may be terminated prior to February 20, 2014, by resolution of the Township Board of Trustees.

**THEREFORE, BE IT RESOLVED**, that the attached Moratorium on Smoking Lounges and Facilities adopted May 20, 2013 shall be extended and all provisions thereof shall remain in effect until February 20, 2014; however, in the event the land use and regulatory ordinances are adopted and in effect prior to February 20, 2014, the moratorium may be terminated prior to February 20, 2014, by resolution of the Township Board of Trustees.
