**AN ORDINANCE TO REPEAL ORDINANCE NO. C-493 RELATED TO ACCEPTANCE OF
THE WATER SUPPLY SYSTEM FOR MAPLE ELEMENTARY SCHOOL**

THE CHARTER TOWNSHIP OF WEST BLOOMFIELD ORDAINS:

Section 1 of Ordinance

On May 20, 1996, Ordinance No. C-493, attached as **Exhibit 1**, was adopted by the Charter Township of West Bloomfield, accepting and acquiring the water supply system installed on the property identified as Parcel Id. No.: 18-31-201-003 located in part of the northeast ¼ of Section 31, West Bloomfield Township, Oakland County, Michigan, in accordance with the Quit Claim Deed from Walled Lake Consolidated Schools to the Charter Township of West Bloomfield dated June 15, 1995, attached as **Exhibit 2**.

Section 2 of Ordinance

The above-referenced water supply system is hereby ABANDONED and no longer part of the water supply system under the jurisdiction of the Water Department of the Charter Township of West Bloomfield as these systems have been replaced by the system accepted in Ordinance No. C-805 adopted by the Charter Township of West Bloomfield on July 17, 2017, and described in the Quit Claim Deed from WBWL LLC, to the Charter Township of West Bloomfield dated July 21, 2017, recorded at Liber 50888, Page 397, Oakland County Register of Deeds.

Section 3 of Ordinance

Ordinance No. C-493 adopted May 20, 1996, effective May 30, 1996 is hereby REPEALED.

Section 4 of Ordinance

This Ordinance shall take effect immediately upon publication.
